All members of the International Friesian Show horse Association believe our conduct matters for both the well-being of the association and its members. We as an association are formed to promote the breeding, care and showing of Friesian Show Horses.

As members our conduct transcends all areas of our goals, and includes how we deal with each other internally, and how we deal with the industry as a whole.

Our Code of Conduct sets forth out basic ethical stands and core values that are applicable to all of us . It helps guide us on how we conduct our association and activities.

All members are responsible for understanding and complying with the IFSHA Code of Conduct. All members are expected to:

- Promote ethical behavior at all shows and activities of IFSHA
- Respect all other members and refrain from disparaging remarks about members, or acts that are unethical.
- Promote the humane care of horses
- Maintain a safe environment for all horses, their riders, owners and participants.
- Promote the Association in a favorable light to the public and the industry.
- Comply with this Code of Conduct, knowing that failure to do so may result in punitive Action by IFSHA, up to and including termination of membership.

- 5. Payment in full must accompany each completed entry. Credit Card payment is available with a 3.5% service charge of the total bill. A separate signed check is to be used for close out of the account at the close of the show.
- 6. Proof of USEF Safe Sport Certification

Signatures

The entry form is not valid unless it is fully completed and has all the proper signatures, membership numbers, and horse information. Each entry must have original signatures of the: Rider/Handler/Driver/ the Owner/Agent and the Trainer. A **TRAINER**, as listed on the entry form, is defined as any adult (18 & Older) who has responsibility for the care, custody or performance of the horse while the horse is on the competition grounds. This adult must sign in the "Trainer's Section". If the rider is considered the trainer, the Rider must sign as the trainer. A parent or guardian signing on behalf of a Junior Exhibitor, must be a USEF Member. The owner may also sign as the trainer if they are present on the show grounds during the event. If not, the entry must be signed by the responsible adult (over 18 Years) that is responsible for the horse during the event. Depending on the circumstances, there also may be a requirement for signature of "Coach". A **COACH**, as listed on the form, is defined as an adult (18 and Older) who gets paid for instructing, teaching, schooling or advising a rider with their horse on the competition grounds. This adult must sign the entry form as coach. If there is no coach, the signature for coach may be left blank.

DRESSAGE: DRESSAGE AT TRYON, HOSTED BY IFSHA

Information for Dressage is found in a separate Prize List, Dressage at Tryon. All Dressage Exhibitors can only enter dressage through the separate prize list.

• Be Advised : Any horse that enters the Dressage Show can NOT return to the USEF IFSHA GRAND NATIONAL SHOW after Midnight on Friday 9/29/23.

USEF Amateur Status

Proof must accompany Amateur Entries. USEF no longer allows "Amateurs" to show with a "Show Pass". To be eligible to show in an Amateur Class, a copy of the competitors USEF Amateur Member Card, along with proof of Safe Sport Certification must be provided to the Show Office.

Junior Exhibitors/Vintage Riders

Riders in these classes must indicate their date of birth on the entry form.

Health Requirements

ALL ENTRIES without a current negative coggins (valid through the show dates) and Required USEF vaccinations, WILL NOT BE PERMITTED TO STABLE ON THE SHOW GROUNDS AND WILL NOT BE PERMITTED TO PARTICIPATE IN THE IFSHA GRAND NATIONAL EVENT. THIS RULE IS FOR ALL HORSES STABLING WITH IFSHA.

USEF Vaccination Rule

 At Federation Licensed Competitions, horses 7 months of age, entering the show grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhino Pneumonitis) vaccinations within six months of entering the show stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request of the Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers or Veterinarian's recommendations. It is recommended that vaccines are administered under the direction of a veterinarian.

1.A In the case of vaccines administered by a veterinarian, the exhibitor upon request by Competition Management, must provide documentation from the veterinarian that the horse in question has received the vaccinations, name of the vaccines and the date of administration.

1.B In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon the request of Competition Management, must provide a receipt of

the vaccine purchase, which is signed by the owner, or agent with care, custody and control of the horse. Vaccine Name, Serial Number, Expiration Date of the Vaccine and the date the vaccine was administered must be supplied to the Competition Management

1.C In the case of a horse that is unable to receive either of the vaccinations due to a history of Adverse Reactions, the exhibitor, upon request by the Competition Management, must provide a letter from the veterinarian on Official Letterhead of the Veterinarian, stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the 7 days prior to entering the show grounds. The log of temperatures is to be provided to the Competition Management, Show Steward, and or Technical Delegate.

Competition Management may not amend or enhance vaccination requirements without prior approval of the USEF Veterinary Committee. BOD 1/17/15 Effective 12/1/15, 1/16/16 Effective 4/1/16

Exhibitors are encouraged to refer to the current Federation Rule Book which is online at <u>www.usef.org</u> A Federation Steward approved by Show Management shall be present to administer these rules at the show.

IFSHA

Owners and their horses are to be members of the IFSHA Association and USEF to participate in the IFSHA Grand National Show & must be current with the USEF Safe Sport Initiative.

Non-owners exhibitors (Jr. Exhibitors/Open) may purchase a IFSHA Show Pass and USEF Show Pass to compete.

Adult Amateur Exhibitors must be members of USEF and be current with the USEF Safe Sport Initiative. IFSHA Memberships (Owner & Horse) are to be completed at the IFSHA Office at least 5 days in advance of the start of the show. Contact Debra Goldmann at <u>ifsha1994@gmail.com</u>

IALHA

Owners and their horses are to be members of the IALHA Association and USEF to participate in the IFSHA Grand National Show. And must be current with USEF Safe Sport Initiative.

Non-owner exhibitors (Jr. Exhibitor/Senior) may purchase a IALHA Show Pass and a USEF Show Pass to compete.

Amateur Exhibitors must be members of USEF & be current with the USEF Safe Sport Initiative.

Minor Exhibitors

Parents/Guardians of minor exhibitors shall not hold the United States Equestrian Federation, the International Friesian Show Horse Association (IFSHA), the International Andalusian Lusitano Horse Association (IALHA), USDF, IFSHA Show Officials and Show Staff, Tryon Equestrian Properties responsible for injury to such a minor. No child's entry will be accepted unless the minor's entry is **SIGNED BY A PARENT OR GUARDIAN.** The Signature of Instructors, Agents or other unrelated persons **will not be accepted.**

USEF Drug Fee

For every horse in USEF classes, a \$23.00 USEF Drugs and Medications Fee will be collected. This Fee does not apply to horses entered only in Opportunity Classes.

USEF Membership/ Non-Member/Proof of Membership/ Show Pass EFFECTIVE 12/1/2022

Per GR 206.9 a Fee of \$45.00 will be collected from participants who are not USEF members that will be competing in USEF classes. Show passes **do not** enable an exhibitor to compete in an Amateur Class. All Amateur Exhibitors must be members of USEF and be current with Safe Sport Certification. All participants (rider, owner, trainer, agent, lease, or coach) must provide to the competition secretary a

current USEF membership number. In the event a rider or owner does not have his/her membership number, he/she must pay a \$45.00 USEF Show Pass Fee. Riders and owners are only eligible for one Show Pass per competition year. Entry Forms

No Entry form will be accepted and considered a **Pre-Entry** unless all items listed above, including all signatures required and full payment of fees are **received together with the entry forms**. Use only the Entry Forms provided by IFSHA, (may photocopy if more than one needed.) Use a **separate form for each horse.** All entries are due by **September 15**th, **2023**.

- Friesian Horses are allowed 5 Performance Classes per day. Halter, Showmanship, Sport Horse in Hand, and Exhibition Classes are exempt from this rule.
- Andalusian/Lusitano Horses are allowed 6 Performance Classes per day. Halter, Showmanship, and Dressage Sport Horse in Hand are exempt from this rule.

Payment

Unless fees are paid at time of show registration/entry, stalls will not be reserved, shavings will not be ordered and back /bridle tags will not be issued.

Each competitor is required to leave a signed open check or credit card authorization with the Show Secretary prior to receiving back/bridle tags. Management may require cash, certified check, cashier's check or money order from any entry who has had a past payment NSF with IFSHA.

Office Fee/Show Office Hours

Every horse entered in the IFSHA Grand National Show will be charged a fee of \$40.00 per horse. The Show Office Will be open on Tuesday, September 26th, 2023 by noon. Ryan Chambers will be the Show Secretary for 2023. On competition days, the Show Office will open 1 hour prior to the start of the beginning of the first session and close 30 minutes after the last class of the day. Show Management will be on the grounds with the same schedule.

Class Adds

Classes may be added to the entry after the closing date with no penalty. The class is to be added by using the official form provided by the Show Office. Class Additions must be done prior to the Class Session and according to this schedule:

- Morning Additions will need to be added by **7:00 PM**, the evening **before**.
- Afternoon Additions will need to be added by **10:00 AM**, the **day** of the class.
- Evening Additions will need to be added by **2:00 PM**, the day of the class.
- All class Add forms will need to be signed by an adult member of the exhibitor's team.

Class Scratches

Class Scratch refunds will no longer be allowed without a note from the vet. You are welcome to Exchange a class for the same horse and rider. Please do this at the time of the scratch.

Failure to Appear

"No Shows" are disruptive to the show and exhibitors will be charged a **\$25.00 Penalty** for each class in which a competitor who entered a class fails to appear for the class and had not informed the office of a class scratch. A second "No Show" by the same entrant will also be charged an additional \$25.00 Penalty and the entry may be considered a scratch for the rest of the day. No Refunds will be granted, and all such penalties will be assessed to the entrant's open check or credit card as pre authorized, prior to leaving the show grounds at the end of the competition. Special Circumstances will of course be given Consideration by the Show Manager.

Substitutions

Once entered, owners may substitute an entrant with submission of veterinary certificate verifying the horse's illness/injury and inability to compete, or proof that the entrant has been sold or deceased. In the event of a substitution the Show Secretary must be notified at least **48 hours** before the show date and a new entry from is to be completed.

Final Bill

Please close out your bill and pick up your final billing statement in the show office by close of the show on Sunday, October 1, 2023. Check over your final billing statement carefully before leaving the show. It will be assumed to be accurate once signed off. Your account will be closed out for you if you do not come to the show office to do so.

Refunds

Entries will only be refunded (less a \$25.00 handling fee) if a Vet Certificate verifying the horse's illness or injury and inability to compete is received within **5 days of the event**. No refunds will be issued on stabling fees, or pre-ordered shavings or hay. Refunds in the event of severe weather, state/local/emergency will be granted at the discretion of IFSHA and show management.

Returned Checks

Returned checks will be assessed a fee of \$50.00 or 10% of the balance due (whichever is greater) and may be subject to the provisions of the USEF rules for non-payment. Unpaid balances will be charged 1.5 % per month and a fee of \$25.00 per month. No payment will be processed a second time after it has been returned by the bank (NSF) and monies still due to the show or IFSHA shall be paid by Certified Check, Cashier's Check or Money Order.

HORSE SHOW MANAGEMENT

Show Management Reserves the Right to Refuse, Accept Conditionally, Cancel any Entries, Disqualify any Rides or Exhibitors, Prohibit Entries and Cancel Awards Prizes without claims for damages as well as to change any course, to cancel or combine any unfilled classes or to reschedule classes and to change rings, judges or other officials. Daily Show Schedule

The Horse Show Office will provide a daily show schedule with updates. Please check with the show office each day for the current updates.

Class Calls

Due to potential unforeseeable problems with any mechanical device, PA Systems, **All Paddock Calls** must be considered a courtesy. It is the responsibility of the exhibitor to be sure that their horse is at the entry gate when the class is ready to begin. Every effort will be made to maintain a working PA system to carry class calls; however, no protest will be upheld, nor will any class be changed on the basis of a PA malfunction. There may be up to a 6 minute break where classes are cancelled. The two minute gate will be adhered to. Breaks and Lunches will be scheduled throughout the day.

Helmets

All exhibitors 18 and younger are required to have a helmet on at all times when mounted. Helmet use is recommended for all riders, regardless of age.

Drug Tests

All horses may be tested at random at any time during the show.

Hoof and Shoe Inspections

Random inspection of toe length, hoof construction, hoof pads and shoe gauge may be performed. See the USEF FR/AL rules for specifications and rules. The USEF Show Steward will have the option to inspect at any time.

Stabling

IFSHA and Show Management will make every effort to accommodate request to be stabled next to or Near other competitors while assigning specific stalls. However, IFSHA, Show Management, and the Barn Manager can make no specific guarantees as to the availability or feasibility of specific stall layouts.

Stalls

Stalls with doors, where occupied with horses, feed or tack will be available for \$150.00 per show week, Tuesday through Sunday. **Move in day is Tuesday, September 26th at 10:00 AM.** All horses must be out of the stalls by Monday at 8:00 AM. Stalls are 10 x 10 with matted clay floors. Wash racks are indoors. The use of nails, Velcro, drilling, duct tape and rubber cement is **STRICTLY PROHIBITED.** The exhibitor is responsible and will be billed for any repairs necessary. All extension cords must have **GFCI Protected on them and a 3 prong plug.** Cords may not be installed through doors. The premise will be checked for compliance.

Sharps Containers

Sharps containers will be located throughout the stabling area and must be used for the disposal of needles and medical sharps. Show Management may fine owners, exhibitors, trainers, exhibitors or agents for improper disposal of needles or medical sharps.

NO SMOKING

SHOW ATTIRE

Jeans or shorts are not acceptable attire for handlers/assistants/horse holder in halter or in hand classes. Please see USEF rules for proper attire for each division Horses are not allowed to use saddle pads that identify any farm, business/owner/breeder.

DOGS

Dogs will be allowed on the competition grounds but **MUST** be on a leash no longer than 6 feet at all times when not in a crate or kennel. Individuals must not lead a dog while mounted. **Dogs are not** allowed in the arenas, in any of the rings or at any entry point of the show arena. In the event that dogs become a problem on the concourse areas, the handler will be asked to remove the dog from the area. Per USEF Rule, GR 1301.6, dog owners who fail to comply with these rules will be issued a Yellow Warning Card and will be subject to penalties under Chapters 6 and 7. **SERVICE DOGS ARE EXEMPT FROM THIS RULE.**

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK. Under the laws of most States, an equine activity sponsor or equine professional is not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. If, despite this Agreement, I, or anyone on my behalf or the minor's behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities as the result of such claim.

The parties agree that this agreement may be electronically signed. The parties agree that the electronic signatures appearing on this agreement are the same as handwritten signatures for the purposes of validity, enforceability, and admissibility.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage competitions, Reining Competitions and Combine Driving Competitions upon payment of a Show Pass Fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline, 2) exhibitions:, 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program);6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions.8) Opportunity Classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11)assistant handlers in Dressage Sport Horse Breeding Classes.

USEF MOTORIZED VEHICAL STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license . The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management is their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF SAFE SPORT TRAINING REQUIREMENTS Approved August 27, 2018 Safe Sport Rule Part 3

- Every USEF member and Federation Participant* shall abide by USEF'S Safe Sport Policy and the U.S. Center for SafeSport Code of Conduct.* As describe by the USEF Safe Sport Policy, Federation Participant is any USEF member or non-member, who participates in, or attends a USEF-Licensed competition or sanctioned event.
- 2. In order to comply with S.534 the Protecting Young Victim's from Sexual Abuse and Safe Sport Authorization Act of 2017, the USEF Safe Sport Policy, and the Center's SafeSport Code of Conduct, every USEF adult member and USEF participant, with the exception of the victim is required to report sexual misconduct within 24 hours to the appropriate authorities and to the U.S. Center for Safe Sport.
- Beginning January 1, 2019. Every USEF adult member with a Competing Membership must complete USEF's Safe Sport Training, as approved by the U.S. Center for SafeSport (the center). BOD 8/27/18

Renewing USEF members must complete SafeSport before competing.

** A copy of your SafeSport Certificate of Completion must be submitted with entry if you are 18 years & over, unless completion is printed on your USEF Membership Card.

MAAPP

It is a recent requirement that all USEF licensed competition participants be notified that 1.) They adhere to the Minor Athlete Abuse Protection Policies (MAAPP) and 2.) how to report violations and abuse allegations.

For background, the federal law known as Protecting Young Victims from Sexual Abuse and SafeSport Authorization Act of 2017 authorizes the US Center for SafeSport (Center) to develop training and policies to prevent abuse, including physical, emotional, and sexual abuse within the US Olympic and Paralympic movement. It also mandates that reasonable procedures are established for one-on-one interactions with minor athletes. To this end the Center has drafted MAAPP which apply to all national governing bodies For sport including the USEF.

A letter from USEF to competition participants where to obtain additional MAAPP Information, including a phone number to report violations, and updated versions of participant forms. Signatures on these new forms will be obtained upon check in at the Show.
