### **FROM WILLIAMS BAY & AREAS SOUTH**

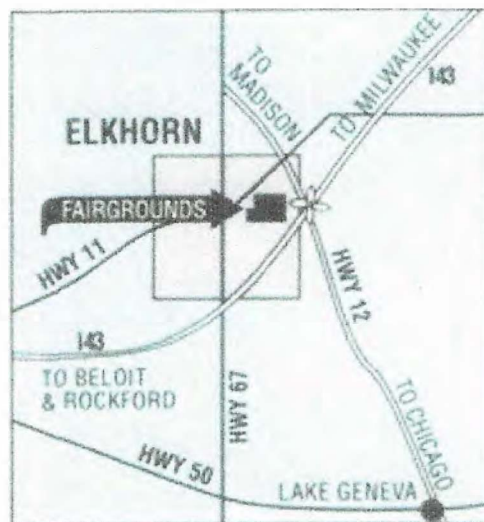

Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

## WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

### EQUINE ACTIVITY LIABILITY ACT WARNING:

CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK.

**Under the laws of most States, an equine activity sponsor or equine professional is not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.**

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

## The Baroque Horse of the Midwest Show Entry Procedures

### **Information to include in Entry Packet for Mail-In Entries:**

1. Completed Show Package to be postmarked by **7/15/2023**. Full payment is to accompany entry package.
  - The entry form is not valid or complete unless it has all the proper signatures, membership numbers and horse information. Each entry form **MUST HAVE ORIGINAL SIGNATURES** of the Rider/Handler/Driver/and the Owner/Agent, and the Trainer. If there is no Trainer, the entry blank must be signed in the Trainer's section if the owner will be present and on the grounds during the show. If not, the entry must be signed by the adult (over 18) who is responsible for the horse during the show. Depending on circumstances, there also may be a requirement for signature of Coach. A parent must sign for any Junior rider. In horse show terms, "Trainer" is the adult responsible for the horse on the show grounds and "Coach" is an individual providing instruction for payment.
2. Copies of Owner/Horse/Exhibitors memberships to be included. (IALHA, IFSHA, USEF).
  - USEF AMATEUR STATUS Proof must accompany Amateur entries. USEF no longer allows Adult Amateurs to show with a "Show Pass". To be eligible to show in an Amateur Class, a copy of the USEF Amateur Member Card must be provided to the Show office.
  - Junior or Vintage Riders in these classes must provide date of birth on entry form.
3. Copies of Safe Sport Certifications.
4. Horse Registrations (Both Sides).
5. Horse Health Records: Negative Coggins, Health Vaccinations as required by USEF, GR 845. In addition, for any horse that is coming from outside of Wisconsin an Interstate Certificate of Health is also required.
6. Payment can be made by credit card, or check. A secondary check may be requested for any additional show expenses. Credit Cards will be charged a 3.5 % fee.

9. Online Entries will be available this year.
10. Phone Entries **ARE NOT** accepted.
11. Exhibitor Back Tags will be issued upon arrival and check in with the Show Secretary with a completed entry.
12. **CLASS SCRATCHES:** Class Scratch refunds will no longer be allowed without a note from the vet. You're welcome to exchange a class for the same horse and rider. Please do this at the time of the Scratch.
13. **SHOW REFUNDS:** Entries will only be refunded (less a \$25 handling fee) if a Vet Certificate verifying the horse's illness or injury and inability to compete is received within 5 days of the show. No refunds will be issued on stabling fees. Refunds in the event of severe weather, state or local emergency will be granted at the discretion of the BHOTM Board of Directors.

## THE BAROQUE HORSE OF THE MIDWEST

### EXHIBITOR INFORMATION

1. The 2023 BHOTM Regional Championship Show is a licensed USEF competition. Every Andalusian, Lusitano, Half A/L, Friesian, Part Friesian and Open to All Breed Horses Shown in the USEF Division classes offered herein are covered by the rules and specifications of the current USEF Rule Book. The rules of the Federation take precedence over the rules of any other association. Exhibitors are encouraged to refer to the current Federation Rule Book which is online at [www.usef.org](http://www.usef.org). A Federation Steward approved by the Show Committee shall be present to administer these rules at the show.
2. **MINOR EXHIBITORS:** Parents/Guardians of minor exhibitors shall not hold the United States Equestrian Federation, The Baroque Horse of the Midwest, IALHA, IFSHA, Show Officials and Show Staff or the Walworth County Agricultural Society/Walworth Country Fair Grounds, Elkhorn, WI, responsible for injury to a minor. No child's entry will be accepted unless the form is signed by THE PARENT or GUARDIAN.
3. **USEF FEE:** For every horse in USEF classes, a \$23 USEF Drugs and Medications fee will be collected. This fee doesn't apply to horses that are entered only in Opportunity classes.
4. **USEF NON-MEMBER SHOW PASS:** Per GR 206.9 a Fee of \$45 will be collected from participants who are not USEF members that will be competing in USEF classes. Show Passes do not enable an exhibitor to compete in an Amateur Class. All Amateurs must be members of USEF.
5. **USEF MEMBERSHIP STATEMENT:** Life, Senior Active and Junior Active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass Fee. Participants in the following classes are exempted from requirements of the rule: 1. Leadline; 2. Exhibitions; 3. Games and Races; 4. Classes for 4-H members; 5. Walk/Trot with the exemption of the Friesian Performance FR218 and Academy classes. (Academy classes are classes limited to horses used regularly in a lesson program); 6. USDF Introductory Level Tests, Pas de Deux and Quadrille Classes; 7. NRHA Endorsed Reining Competitions; 8. Opportunity classes; 9. Citizens of other nations who have proof, in English, of current membership and in good standing of their own National Federation; 10. USEA Beginner Novice division; and 11. Assistant handlers in Dressage Sport Horses Breeding classes.
6. **USEF MOTOR VEHICLE STATEMENT:** Minors that do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind. Including, but not limited

to golf carts, motorcycles, scooters or farm utility vehicles, on the competition grounds of a licensed competition. Minors who have a valid temporary license may operate the above -described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motor vehicle in violation of this rule are solely responsible for any damages, claim, losses, or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management is their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a device in violation of this rule is accountable and may be subject to penalties. Wheel chairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

7. **CLASS CALLS:** Due to potential unforeseeable problems with any mechanical device, PA Systems and class calls MUST be considered a courtesy. It is the responsibility of the exhibitor to be sure that his /her horse is at the entry gate when the class is ready to begin. Every effort will be made to maintain a working PA system to carry class calls, however, no protest will be upheld, nor will any class be changed on the basis of a PA malfunction. There may be up to 6-minute hold where classes may have been cancelled. The Two Minute Gate Rule will be adhered to. Breaks will be scheduled throughout the day.
8. **HELMETS:** All exhibitors, 18 years and under are required to have a helmet on at all times when mounted. Helmet use is recommended for all riders, regardless of age. Per DR 120.6, all riders competing in Dressage, must wear a helmet at all times when mounted, including warm up days.
9. **SHOW ATTIRE:** No handler, exhibitor, rider or driver shall be allowed to enter a class wearing clothing that displays logos or wording that would identify any farm/business/owner/breeder. Jeans or shorts are not acceptable attire for handlers/assistants/horse holders in halter or in hand classes. Please see USEF rules for proper attire for each division. Horses are not allowed to use saddle pads that identify any farm/business/owner/breeder.
10. **SHARPS:** Sharps containers are available in the barn and must be used for the disposal of needles and other sharp instruments. Show Management may fine owners, agents, trainers, exhibitors up to \$1000 for improper disposal of needles or sharp instruments.

11. **DRUG TESTS:** All Horses may be drug tested on a random basis.
12. **HOOF AND SHOW INSPECTION:** Random inspection of toe length, hoof construction, hoof pads and shoe gauge may be performed. See USEF A/L and FR rules for specifications. The USEF Show Steward will have the option to inspect at any time.
13. There is NO SMOKING IN BARNS OR SHOW ARENA AREAS.
14. **HORSE SHOW EXECUTIVE COMMITTEE:** This committee reserves the right to itself, to interpret all questions and conditions in regard to or arising out of, or incident to the show, without claim for damages or recourse of any kind. Any questions not covered in these rules and regulations shall be decided by the Horse Show Executive Committee and their decision to be final. The Committee shall consist of the Show Manager, Show Secretary and USEF Show Steward.
15. **FINAL BILL:** Please close out your bill and pick up your final billing statement in the show office by close of the show on Sunday, August 6, 2023. Check over your billing statement carefully before leaving; it will be assumed to be accurate once signed off. Your account will be closed out for you if you do not wish to come to the show office.
16. **HORSE SHOW MANAGEMENT:** Management reserves the right to refuse, accept conditionally or cancel any entries, disqualify any rides or exhibitors, prohibit entries and cancel awarded prizes without claims for damages as well as to change any course, to cancel or combine any unfilled classes or to reschedule classes and change rings, judges or other officials. The class schedule in this booklet is Tentative. Show Management reserves the right to adjust the class schedule and class order. If entries warrant, performance may begin earlier or later than published. If entries warrant classes may be split or combined. Show Management also reserves the right to change, reschedule or cancel classes due to scheduling or weather.
17. **AWARDS:** Regional Championship classes will be awarded Champion, Reserve Champion and Top 5 Ribbons, with placing to 15. USEF classes will be awarded ribbons 1<sup>st</sup> thru 6<sup>th</sup> place. Opportunity classes will be awarded ribbons 1<sup>st</sup> thru 6<sup>th</sup> place. USAWE classes will be awarded ribbons 1<sup>st</sup> thru 6<sup>th</sup> place.
18. Signature of the Exhibitor/Owner/Parent or Guardian of Junior Exhibitor on the entry form of the Baroque Horse of the Midwest Regional Championship show entitles The Baroque Horse of the Midwest/USEF/IFSHA/IALHA/USAWE to use any photographic images taken during the event for promotional use of the associations in print/web sites/videos and social media.
19. The 2023 BHOTM Show is licensed to host USAWE Region 5 Working Equitation Show (License 23-036). All USAWE participants are covered by the rules and specifications of the current USAWE Rule Book.

# USEF SAFE SPORT TRAINING REQUIREMENTS

Approved August 27, 2018

## Safe Sport Rule Part 3

1. Every USEF member and Federation Participant\* shall abide by USEF'S Safe Sport Policy and the U.S. Center for SafeSport Code of Conduct.\* As describe by the USEF Safe Sport Policy, Federation Participant is any USEF member or non-member, who participates in, or attends a USEF-Licensed competition or sanctioned event.
2. In order to comply with S.534 the Protecting Young Victim's from Sexual Abuse and Safe Sport Authorization Act of 2017, the USEF Safe Sport Policy, and the Center's SafeSport Code of Conduct, every USEF adult member and USEF participant, with the exception of the victim is required to report sexual misconduct within 24 hours to the appropriate authorities and to the U.S. Center for Safe Sport.
3. Beginning January 1, 2019. Every USEF adult member with a Competing Membership must complete USEF's Safe Sport Training, as approved by the U.S. Center for SafeSport (the center). BOD 8/27/18  
Renewing USEF members must complete SafeSport before competing.  
\*\* A copy of your SafeSport Certificate of Completion must be submitted with entry if you are 18 years & over, unless completion is printed on your USEF Membership Card.

## MAAPP

It is a recent requirement that all USEF licensed competition participants be notified that 1.) They adhere to the Minor Athlete Abuse Protection Policies (MAAPP) and 2.) how to report violations and abuse allegations.

For background, the federal law known as Protecting Young Victims from Sexual Abuse and SafeSport Authorization Act of 2017 authorizes the US Center for SafeSport (Center) to develop training and policies to prevent abuse, including physical, emotional, and sexual abuse within the US Olympic and Paralympic movement. It also mandates that reasonable procedures are established for one-on-one interactions with minor athletes. To this end the Center has drafted MAAPP which apply to all national governing bodies For sport including the USEF.

A letter from USEF to competition participants where to obtain additional MAAPP Information, including a phone number to report violations, and updated versions of participant forms. Signatures on these new forms will be obtained upon check in at the Show.

## **USDF STATEMENT ON ANIMAL WELFARE**

The United State Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systemic manner. As a result, the horse becomes capable, comfortable and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.
